

## Schedule 6. Land designated for infrastructure

- (1) The tables below note land designated for infrastructure by the Minister or by local government.
- (2) The tables below identify the land, state the type of infrastructure for which the land was designated, state the day the designation was made, and where applicable, refer to any matters included as part of the designation.
- (3) Where applicable, designation matters may include the following:
- requirements about works or use of the land for the infrastructure, including the height, shape, bulk or location of the works on the land, vehicular access to the land, vehicular and pedestrian circulation on the land, hours of operation of the use, landscaping on the land and ancillary uses of the land; and
  - other requirements designed to lessen the impacts of the works or the use of the land for infrastructure, including procedures for environmental management.
